RETURNING HORNET VISITS SCHOOL.** We received this interesting email from Katherine Dorsey Larrabee (62): "I visited Surrattsville several years ago to take photos for a 50th Reunion booklet for the Class of 62. I met the principal, new at the time. She was inspiring and also welcoming. She invited me to visit an after-school choir rehearsal. Wow! I don't recall a choir quite like that during my days at Surratts. I came away feeling very proud of the SHS of today. The building and grounds look good too! Katherine"

[Ed Note: A number of returning Hornets have made similar comments to us, including similar comments about Surrattsville's outstanding Music Department. **6. SURRATTSVILLE SPORTS HISTORY.** Two of Surrattsville's most storied sports teams include the 1965 State boys' basketball champs, and the Coach Lew Jenkins wrestling dynasty (especially the years 1968-1973 when the teams went 59-7-1, and it really wasn't that close as the losses were squeakers to much larger schools!). In response to our request for additional bits of Surrattsville sports history, we received this interesting email from Chuck Teubner (64): "In 1962, when I was a sophomore, we won the State A basketball championship. Wayne Eaton, Bob Johnson and Jim Byroads were the stars. Wayne Eaton got a basketball scholarship to High Point University, and a few years later Bob Vaughn, the coach, got the head coaching job there. Although we played mostly JV, Larry Munyon, Bob Riley and I got to dress for the state tournament games – very exciting for 15 year olds. In 1964 we lost in overtime in the AA semifinals to Towson High School. Our big star and All-Met was Don Rhoades, who was killed the following fall in a car accident in New Mexico where he went to school. Other players were Larry Munyon, Bob (Wease) Riley, Don Evans, etc. and I was the other guard – very large guard for those days at 6'2" and 220 lbs. Other players were Norman Carmichael, our junior, 6'11" center, who was very tall for those times. He played his best game and was the key player in winning the state AA tournament the next year at Cole Field House against Alleghany. I was a spectator at the game as a freshman at Maryland. Regards, Chuck"

[Ed Note: We'd love to have more stories of Surrattsville's athletic past. And some of our readers might recall the article we ran in May about the ground-breaking Towson High star of the 1964 game mentioned by Chuck, Billy Jones.]

Although the Hornets lost to Ft. Hill High, they scored 20 points in the effort to cap yet another fantastic season and to finish fourth in Surrattsville's league in the entire State.

8. 1954 GRAD RECEIVES MAJOR MUSIC AWARD. We recently learned that Helen Bovbjerg Niedung (54) recently received the the first Florida State Music Teachers Distinguished Teacher of the Year Award. Recipients of this new award must have been a member of the Florida State Music Teacher's organization for at least 20 years, have served in positions at the local, district and State levels, and have had students who have won various competitions through the years. Helen earned her music degree at the Eastman School of Music in Rochester, NY, a pursued post-graduate studies in Germany and Italy. Helen also had an international opera and concert career, and taught at the collegiate level and privately. Helen's students have won countless vocal competitions.

**10.** <u>CLASS OF 39 FEATURED IN POST ARTICLE, con't.</u> Here is a continuation of an item in the last e-Notice about a June 25, 1984 Washington Post article by Eugene Meyer sent in by Paul Monaghan (59):

"Class of '39 Surrattsville High Recalled ... County students were tracked then in academic, commercial and general courses. Few aspired to college or the professions. Strayer's Business School in Washington actively recruited Surrattsville graduates, mainly girls, who almost invariably took commercial courses. They hoped for what Jean Hurley Wilhelm described as a "big-paying government job" as a typist or secretary. She wanted to teach but became a school cafeteria worker instead. Long after graduation, at least three of the women got nursing or related jobs.

Some who left the farm went to work at the Navy Yard in Washington. Eugene Tayman was a mailman there. John Zajic (whose tap dancing skills earned him the high school nickname "Fred Astaire") worked at the torpedo factory in Alexandria. Only "Junior" Loveless, whose father was postmaster and also sold candy and Philco radios, went directly to college and graduated. "John [White] and I wanted to be G-men," said Ken Smith, who was the class athlete and married Audrey Gemeny. "We were -- garbage men," running a regular garbage route in the District to get feed for the White family's pigs.

Within three years of graduation, most of the men in the Surrattsville Class of 39 had gone to war. Hans Warffemius joined the infantry and came home with a shrapnel wound and a Purple Heart. Loveless became a naval officer, but remained stateside. Ken Smith joined the Navy and was stationed at Pearl Harbor. Jim Tippett was a glider mechanic who prepared the planes for D-Day. Barrow Neale flew 50 bombing missions over Europe as a B-24 pilot. Joe Edelen got to see the world but has never again lived anywhere but the home farm outside Clinton. Hartwell Trueman had "right bad" stomach ulcers and was classified 4-F. Sgt. Eugene Tayman was killed in action in Germany in March 1945, leaving a wife and two young children.

On the home front, Christina Gwynn worked at the draft board in Upper Marlboro. During a vacation to Virginia Beach with classmate Lois Hogue she met a Coast Guardsman whom she later married. Opal Price met her band leader husband while she was working as a statistician for the British Ministry of Supply in Washington. In the immediate postwar era, Tippett bought

a new Cape Cod subdivision house with a 4 percent VA loan. Warffemius went to the University of Maryland on the GI Bill, but quit after two years. John White and his brother, both veterans, opened G.I. Liquors in Morningside near the Andrews base."
