**1. <u>FOUNDATION AWARDS 2015 SCHOLARSHIPS.</u>** We are proud to announce these absolutely outstanding recipients of the Foundation's 2015 scholarships:

ELSA TLAPECHCO – *THOMAS V. MILLER, SR. SCHOLARSHIP*. While at Surrattsville, Elsa was an honor roll student who maintained a 3.3 GPA, was an SGA member in grades 10, 11 and 12, served as SGA President in grades 11 and 12, was founder and President of the Hispanic American Leadership Organization, served as a Student Leader and Peer Mediator, was a member of the Art Club, and played on the Tennis Team. Outside of school, Elsa volunteered at the Humane Society, at the Special Olympics and at area animal shelters. Elsa plans to attend Stevenson University in the Fall majoring in biology, and to attend veterinarian school after college.

IYANA DOWNIE - *ESTHER CLIFTON MILLER SCHOLARSHIP*. While at Surrattsville, Iyana maintained a 3.6 GPA while completing AP classes in psychology, pre-calculus, computer graphics and biology. Iyana served as Wing Commander (the highest student position) in the School's award-winning AFJROTC program, where she received numerous citations and awards. Iyana was the President of the National Honor Society and of G.E.M.S. (Girls Empowered Meeting With Success), and served as a Peer Mediator. Outside of School, Iyana was a Clinton Library Volunteer Reader, an escort at the Mt. Vernon Slave Memorial, a volunteer for Can You Care Food Drive, Children Fighting For Cancer, and the Special Olympics, and worked as a child care provider. (Iyana received the second highest number of community service hours – 638.5 -- in the Class of 2015.) Iyana plans to attend Virginia Wesleyan University in the Fall, and to major in child psychology.

JANINE HUME-DAWSON. While at Surrattsville, Janine was on the Honor Roll and the Principal's List, and maintained a 3.1 GPA. She was a member of the National Honor Society, the SGA, the Drill Team, the Morning Announcement Team, G.E.M.S. (Girls Empowered Meeting With Success), the Tennis Team, the Choir, and led the Breast Cancer Awareness Campaign and the Can You Care Food Drive. Janine plans to attend Alcorn State in the Fall as an AFJROTC student, majoring in psychology and minoring in pre-law. After college, Janine hopes to become a JAG lawyer.

ALEXIS NICOLE SMITH. Alexis maintained a 3.98 GPA at Surrattsville while taking AP calculus and statistics, and was on the Principal's Honor Roll. She was a member of the SGA, and served as its Treasurer and Historian. She was Editor of the Yearbook, served as a Student Leader and class officer, was a member of the Track and Volleyball teams, and served on the

Morning Announcement Team. In the Marching Band, Alexis served as Section Leader, Student Director and Drum Major. Alexis plans to attend Ohio State University in the Fall, majoring in athletic training.

LAWRENCE BROWN II. At Surrattsville, Lawrence maintained a GPA of 3.96, while taking AP courses in statistics and psychology, and being awarded the Principal's Award in grades 10 and 11. He was a member of NHG, the Student Leadership Club, the History Club, the Society of Torch and Laurel, the Congress of Future Medical Leaders, and the Indoor and Outdoor Track Teams. Lawrence was awarded Second Place in the Write-a-Book Competition and First Place and Second Place at School Science Fairs. In the Fall Lawrence plans to attend Coastal Carolina University to pursue a healthcare career.

**2. FOUNDATION ANNOUNCES 2015 ACHIEVEMENT AWARD RECIPIENTS.** The Foundation also is proud to announce this year's duo of truly extraordinary Achievement Award recipients!

SENIOR MASTER SERGEANT PHYLLIS G. DICKERSON. Senior Master Sergeant Dickerson, who is retiring in 2015, is one of the instructors in Surrattsville's multi-award winning Air Force Junior Reserve Officer Training Corps program. Affectionately known as "Sgt. D" and "the Mother of the AFJROTC unit," she serves as a mentor and leader of the outstanding students in the program, and is cited by many as a primary reason for the program's many successes. SMSgt Dickerson also is very active as a volunteer at her church and in the community.

SMSgt Dickerson retired from active duty in the Air Force in 1994 to take her instructor position at Surrattsville, and immediately began to work with Col. Umstead to build the AFJROTC program into one of the top programs of its kind in the country.

SMSgt Dickerson's many accomplishments began early in life. She attended Essex High School in Virginia and excelled across the entire spectrum of school activities. She was very active in the school Choir, Future Business Leaders of America, Future Homemakers of America, Cheerleaders, and a four-year letterman on the Track and Field Team. Her exceptional athletic performance earned her a position on the Virginia All-State Track and Field team for four consecutive years.

After graduating from high school in June 1973, SMSgt Dickerson enlisted in the Air Force. Her Air Force assignments included Edwards AFB, CA where she was involve with the test program for several new military weapon systems, Okinawa, Japan where she became an inspector of several different aircraft assigned to her, Altus, Oklahoma where she continued her career as an inspector, and Incerlik, Turkey where she was a member of the transient maintenance unit which serviced all tanker, cargo, and fighter aircraft in that region. Next, SMSgt Dickerson was assigned to Andrews AFB where she worked in the Transient Maintenance Branch to support all incoming and outgoing aircraft traffic in support of the White House and the Pentagon. She was later assigned as Crew Chief of the Vice President's aircraft which on many occasions backed-up the President of the United States. Her next assignment was to Royal Air Force Mildenhall, England, where she held the role as Production Superintendent of flightline maintenance. Sergeant Dickerson was directly involved in Operations Desert Storm, Desert Shield, and Provide Comfort. In July 1993, SMSgt Dickerson returned to Andrews to serve as Superintendent of the Transient Maintenance Section, her last active duty posting before coming to Surrattsville.

SMSgt Dickerson's military decorations include the Air Force Meritorious Service Medal with one bronze oak leaf cluster, the Air Force Commendation Medal with two bronze oak leaf clusters, and the Air Force Good Conduct Medal with one silver oak leaf cluster and one bronze oak leaf cluster. And, perhaps most impressively, she was named AFJROTC Instructor of the Year in 1996-1997!

LT. COL. DARYL UMSTEAD. Lieutenant Colonel Umstead has been the Senior Aerospace Science Instructor in Surrattsville's multi-award winning Air Force Junior Reserve Officer Training Corps since August 1997. In this role, he is responsible for the management and administration of the program in accordance with Department of Defense, Air Force and AFJROTC guidance. Lt. Col. Umstead is widely recognized as a primary force behind the absolutely extraordinary successes of the School's AFJROTC program.

Lt. Col. Umstead graduated from Hillside High School in North Carolina and earned a Bachelor's of Science Degree in Industrial Technology from North Carolina Agricultural and Technical State University. He next obtained a Master's of Arts degree in Human Resources Management from Pepperdine University. He was commissioned a Second Lieutenant through AFROTC and attended the Communications Electronics Maintenance Officers Course at Keesler Air Force Base, Mississippi. His duties included communications, logistics and educational assignments in South Carolina, the Philippines, Virginia, Illinois, California, Washington, DC, Naples, Italy and back to DC where he served as a Professor of Aerospace Studies at Howard University. He retired from active duty on the ceremonial lawn at Bolling Air Force Base in 1997 to begin his tenure at Surrattsville.

Lt. Col. Umstead's military awards include the Defense Meritorious Service Medal with two oak leaf clusters, the Meritorious Service Medal with four oak leaf clusters, and the Air Force Commendation Medal. Lt. Col. Umstead also has been a great supporter of the Foundation since its establishment, even serving on the Foundation Board for a number of years.

A Note about Surrattsville's AFJROTC Program: In the eyes of many, no two individuals have been more instrumental in the extraordinary successes of the School's AFJROTC program than Lt. Col. Umstead and Senior Master Sergeant Dickerson. The School's AFJROTC was established with the initial unique objective of establishing a 9<sup>th</sup> grade (and beyond) transitional program that includes mentoring, guidance, career assessment, interest inventories, test-taking skills, study skills, portfolio development, and post-secondary school opportunities exploration

The program also stresses reading, writing and vocabulary development to prepare cadets for the PSAT and SAT tests, and has included post-test follow-up and AFJROTC-led prep classes (at one time serving 500 students with six instructors). The program also supports students in their efforts to complete their required community service hours.

Each Fall, the program provides off-site training to cadets in uniform wear, basic customs and courtesy, physical fitness awareness and drill movements. As a result of this intensive preparation, the Surrattsville program continually places first in competitions in Maryland, Delaware, New Jersey, North Carolina, and Virginia. And the program even provides waltz lessons in preparation for the annual military ball!

Despite having its instructor total cut from six to four, the program continued to earn the very prestigious AFJROTC Honor Unit Status. An alumni program brings Surrattsville grads back to the School to inform cadets about life after high school and to emphasize the importance of high school preparatory work. For 15 years, the program sponsored Clinton's great community parade. The program's Kitty Hawk Honors group spearheads tutoring and mentoring efforts which keep the programs academic goals alive and which has resulted in many years of cadets qualifying as Surrattsville's valedictorians and salutatorians.

Each year, the program sponsors "Curriculum in Action" field trips to places like the White House and Andrews AFB. The program stresses resume development through summer leadership programs like Boys' and Girls' State and the program's own Cadet Officer Leadership Program. Surrattsville's AFJROTC Unit MD-942 was named an AFJROTC Outstanding Unit in 2000, Distinguished Unit in 2012, and Distinguished Unit with Merit in 2013. It has always been committed to being "the best of the best," and a recent Air Force inspector noted that the Surrattsville unit is "one of the nation's premier units, serving as a model for other units to follow."

The achievements and successes of these great kids under the tutelage of SMSgt. Dickerson and Lt. Col. Umstead cannot be overstated. Although these two exemplary educators will be sorely missed after their retirement, the foundation they have built over the decades will certainly benefit Surrattsville's AFJROTC cadets for years to come. Congratulations and best wishes to these outstanding role models, instructors and mentors who have provided so much to the students at Surrattsville!

Here are overviews of these great new endowed funds to benefit Surrattsville graduates:

The Foundation's Thomas V. Miller, Sr. ('36) Memorial Scholarship was endowed by Nancy Miller ('67) in 2014 honor of her late father. Nancy notes, "My father was born in Clinton in 1919 and died here in 1991. After graduating from Surrattsville in 1936, he briefly attended the University of Maryland but decided that he would rather work than study, and thereafter worked six days a week, at least 12 hours a day, until the day he died, to support his wife and ten children."

This annual scholarship is granted to a deserving, hardworking senior, with special preferences given to applicants who have to work at an outside job while in school. Special consideration also is given to applicants who might be planning a post-Surrattsville educational path that does not include a traditional college experience.

The Foundation's Esther Clifton Miller Memorial Scholarship was endowed by Nancy Miller ('67) in 2014 honor of her late mother. This annual scholarship is granted to a graduating senior with a preference for seniors planning to pursue an education degree and a career as a teacher. Nancy notes, "At age 19, my mother was then the youngest person ever to be certified to be a teacher in the District of Columbia. A native of D.C., she graduated from Eastern High School when she was 15, and Wilson Teachers College at age 19. She taught in the public schools of

the District until she moved to Clinton after her marriage to my father, Thomas V. Miller, Sr. She was an occasional substitute teacher at Surrattsville Elementary School, she taught CCD religion classes to elementary-age children at St. John's Catholic Church in Clinton every Saturday, and was the leader of numerous Bluebird and Camp Fire Girl troops of all ages that met at our house every Friday after school. And all the while raising 10 children! She loved everything about children and teaching. I know she would be pleased to know that this Scholarship will be used to help Surrattsville graduates become teachers."

The Foundation is very grateful to Nancy for her extraordinary generosity to benefit the great kids at Surratts.

**9.** MORE MEMORIES FROM LIFE IN CLINTON. We received these evocative and interesting memories from Bill Crawford (62),bcraw44@gmail.com:

Midnight At The A&P With Red Mike. I was talking recently with a classmate about our departed brother, Mike O'Connell (61). This conversation spurred me to dip deep into my Vault Of Clinton Memories. The following is an unedited rant which reflects mostly stream of consciousness remembrances. Mike, Ralph Whittington (63), and I were going to a Washington Senators game on the street car. Sparks and baseball! Ralph's mom, Big Mae Whittington, drove us from Clinton to Barney Circle where we caught the trolley up to 7th and Florida Ave., NE. Big Mae wrote the local Clinton social column for the county paper. She carefully chronicled key events such as when three couples gathered at a home for dinner. She often ended her gossipy missive with the curt observation that "a good time was had by all!" She spoke very fast and very loud. When she let us out at Barney Circle she admonished Mike to try to help us to be careful. Heading into the city that wouldn't be easy, but she allowed as how Mike was a "good Catholic boy" and God would keep us safe! The visiting team that night in the summer of 1959 was the Go-Go White Sox managed by the brilliant El Señor, Al Lopez. The Pale Hose were kicking the invincible Yankees a#@ that year, brandishing an early brand of

Billy Ball keyed by the likes the aging Ted "Big Klu" Kluzewski, the fiery future Hall Of Famer, Nellie Fox, and their classy mound ace, Billy Pierce. They manufactured runs with bunts, aggressive base running and the occasional bomb from Big Klu. They easily handled the Nats that night and we were eventually homeward bound. We got off the streetcar back at Barney Circle.

Ralph's dad was to pick us up at the south end of the Anacostia River Bridge. We were walking across to go to the Little Tavern hamburger palace which was nestled in a cluster of stores beyond the Bridge beside Morton's and the movie theater. Great greasy burgers for 25 cents each by the bag full. Mike was already a basketball star even at 15. All the big Catholic schools were pressuring him to defect down town to lead them to glory. But Mike was a Hornet. A year later he helped us win the Maryland State Class C championship on a team led by Jess "The Big Train" McClain and Martin "Goose" Padgett. I thought of O'Connell as "Red Mike" because of his rusty hair. I rarely called him that but when I did he grinned tolerantly making allowances for the skinny bespectacled nerd that I was. Mike plied the halls of SHS carrying a heavy brown briefcase bulging with books and papers. He was a bit like the nutty professor but in a good way. He would finish first in his class, gain induction into Phi Beta Kappa at Dartmouth, and publish a stem winding senior thesis before leaving for grad school in Madison, Wisconsin. He played basketball in Hanover where my good friend Jim Provencher enrolled and played football Mike's senior year. Mike's writing talents were most visible at SHS when he posted a crafty basketball column hand written on the locker room wall. He wrote under the nom de plume Johnny Green, the high leaping NY Knick that he venerated. These lively columns served as precursors for the professional sports writing that he would do later in Wisconsin.

Mike was serious student athlete who told people that he usually went to bed by 9:30. It was now midnight and he was bleary eyed and sleep deprived. Somehow he got a little ahead of Ralph and me at the other end of the bridge. He made his way slowly up to a row of storefronts and he stood at a wide glass door. He began to shake the door vigorously. Ralph's high pitched voice squealed in my ear. "Craw! He is trying to get into the A&P!" And so he was. The grocery store now long closed was next to our targeted Little Tavern. Mike was blitzed--way past his appointed bedtime. We never really let him forget that night. If I passed him in the hall or locker room or even at football practice in a Staush Burak huddle I would stare at him in mock seriousness and intone: "Tonight, the A&P, at midnight." He would drop his head in embarrassment, grin just a little, and let loose that infectious chuckle. I took that memory on my life's journey. I think Mike did too. Later, when I began to write sports for my small college's newspaper I contemplated turning in a byline of "Johnny Green, II". I chickened out but I always tried to write just like Red Mike. He was one of the best and gentlest people that I ever knew. I hope that this piece lives up to his standard. It ain't easy. Bill"

10. ... AND SPEAKING OF BILL CRAWFORD (62). Bill also shared this lovely note he received in response to memories of his we recently published about his friend in Vietnam, Oliver Noonan: Hello Bill: I just happened across your moving memoir of my childhood friend

I was crossing Mission Street in San Francisco when I saw the Chronicle headline AP Photog Killed in VN. It still hurts. Thought you might enjoy this link.

## In Memoriam
